Notes: Cheryl Cook introduced Sara McInerny and Dave Tilly. Tilly discussed legislation and how the IRRC was established along with:

- Work of the IRRC
- Priorities
- Relationship with the Department of Education
- Location

Tilly shared how the broad relationships work (i.e. between the Center, Department of Education, schools, leadership groups). Tilly briefly mentioned the by-laws can be found on the IRRC website.

Council members discussed and were encouraged to speak with local legislatures and attend the IRRC legislative breakfast in order to "guide" the legislation.

McInerny took over to discuss the priorities of the Center (set by the Advisory/Department of Education) and the need for these collaborative relationships.

Priorities of the Center:

- Evidence-based intervention and instructional strategies- Department of Education is leading this with the support of the Center.
- Intensive Summer Reading Program- The Center is leading this work and will be discussed further in a later portion of this meeting.
- School-community partnerships- The Center is currently doing work with different groups (Family Resources).
- Collaborative active relationships- Currently working with several different groups including: area education agencies (AEAs), institutes of higher education (IHEs), Department of Education, etc.

McInerny further discussed the by-laws for council members. The major components of the by-laws are:

- Membership

- Term of Office
- Conflict of Interest

Cook asked council members to speak with their neighbor about their current work and how it relates to the work of the Center. Council members then shared their discussions in regards to the work they are doing/have done within their groups.

Cook introduced Thomas Mayes to discuss the legal aspect of the Council (i.e. regulations, by-laws). Mayes reviewed the purpose of the by-laws and why they are important to the council, especially highlighting the Conflict of Interest portion of the by-laws.

Notes: Cheryl Cook shared news articles and work which the IRRC has been a part of in the past four months, including the Iowa's Early Warning System for Literacy video (**b**). Michelle Hosp shared where the video can be found on the IRRC website.

Michelle Hosp shared the discussions between herself and the school members who were part of the Iowa Early Warning System video filmed at Hoover Elementary.

Dave Tilly shared information regarding the assessments and how many districts have currently started using Formative Assessment System for Teachers (FAST) and Iowa TIER, a data system with the capability to house universal screening data. (93,000 students have begun these assessments; 63,000 of these students have completed the assessments). Tilly further discussed the successes and issues within FAST/TIER and the continued growth of the system.

Tilly discussed with the council the database and availability of data from the FAST/lowa TIER system.

Discussion about the purpose of these assessments and Chapter 279.68 ensued.

Sara McInerny shared the FY15 Communication Plan (**d**) with the council and asked for their feedback on the document. Council members broke into groups to discuss questions in regards to the Communication Plan:

- Please identify the top 4-5 priority groups.

McInerny asked Council members to share out the discussions they had in their groups (see FY15 Communication Plan document).

Notes: IRRC Initiatives:

Cheryl Cook introduced the initiatives of the Center. Initiatives include:

a) Family Resources Project and Rollout

Cook shared that the Family Resource project will be launched this fall, along with the new website refresh. The group discussed promotion and collaboration efforts underway to ensure the successful rollout of the Family Resources, including AEAs, local education agencies (LEAs), and community partners.

Cook and IRRC team member Sally Huddle explained the current work with the Center in collecting mobile applications for review.

b) English Language Learners Family Resources Project

Cheryl Cook referred to the May 2014 Advisory Council meeting and the priority set forth around the need for a specific set of resources for English Language Learners (ELL) and their families. Discussion on the process and current work the Center is doing on the ELL project ensued.

Amy Hutchison and Jobi Lawrence discussed the ELL Small Task Team work process and plan.

c) Struggling Readers

Michelle Hosp shared that the work on Struggling Readers will possibly start at a later time. Hosp shared the Center will look at this work at the end of the year to see what needs done further for Struggling Readers.

d) FAST, IGDIs, and Iowa TIER (IHE trainings)

Michelle Hosp discussed the success of the Early Warning System Trainings for Institutes of Higher Education (IHEs), which the Center held this past year.

Sally Huddle shared the results of a post-training survey the Center sent out to attendees of the Early Warning System training, which showed 96 percent were interested in follow-up webinars.

A video highlighting the participants and work during the IHE training was shown to the Council.

e) Intensive Interventions

Barbara Ohlund shared updates on the Intensive Interventions work. The release date of what interventions could potentially be identified for the state will be September 29, 2014.

f) Intensive Summer Reading Program

Michelle Hosp gave an update on the Intensive Summer Reading Program work and the compilation of guidelines for this work. Hosp shared the upcoming work on the Landscape Assessment, which will be compiled by the three regent universities.

Hosp discussed the process of the Intensive Summer Reading work, which includes:

- Gathering a small task team to assemble and develop guidelines and criteria.
- Identify and work with a national expert; and
- Compilation of landscape assessment by three regent universities.

The guidelines for Intensive Summer Reading Programs will be implemented in 2017 in schools statewide and are targeted to be available Spring 2015. Discussion continued on how this guidance will be used in schools.

Ohlund shared the major components of Chapter 279.68. Discussion on the definitions of these components (students who are progressing, students at risk, students who exhibit Substantial Deficiency) continued.

Floor was opened up for questions.

The Council further discussed suggested ways to implement Universal Screening and Progress Monitoring. Council members shared ways they had used the Universal Screening and Progress Monitoring assessments in their schools (i.e. Swat Teams).
